


#### **Ouster of Ron Weiser Popular**

As the head of the MIGOP and a UM Board of Regent member, Ron Weiser holds two prominent roles in Michigan. Poll respondents think he should resign given his recent comments regarding Whitmer, Benson and Nessel. While election rights advocates and clerks have strong opinions about the 39bill "election reform" package rolled out by Republicans, the public still has some uncertainty about it from a number of angles. But the messages around voter suppression and ties to national rightwing efforts seemed to sway opinions. Michigan Senate Republicans recently introduced a 39-bill package targeting election reforms. 

Many local clerks and voting rights advocates have said the Republican-sponsored, 39-bill voting package will make it more difficult for people to vote by requiring additional steps like sending in a photocopy of your ID to receive an absentee ballot and limiting the times when people can drop off absentee ballots at drop boxes. 



## Lucido's Nursing Home Crusade Not Landing

Michigan Republicans and Macomb County Prosecutor Peter Lucido have been hammering away at talking points trying to connect Gov. Whitmer and deaths in nursing homes from COVID, despite data showing their narrative is bogus. A majority of respondents do not blame Whitmer for nursing home deaths – and actually support her handling of the crisis over Republicans'.





### Real Transparency Reforms Super Popular

For the second Lake Effect in a row, we are seeing massive support for Progress Michigan-announced ballot efforts around FOIA and lobbying reform. The temperature on the lesser version of FOIA reform moving through the legislature gets a lukewarm reception. The legislature is debating bills to open the Governor's office up to Freedom of Information Act requests but that also would create a separate system with less transparency for legislative records requests. Do you support or oppose this bill package?
