We have granted your request in part and/or have redacted information from the records based on the following exemption(s):

PRIVACY, MCL 15.243 13 (1)(a):

"Information of a personal nature which is clearly an unwarranted invasion of an individual's privacy." Namely, information including incident locations, addresses, victim, witness and juvenile identities and injuries under HIPPA .

In the event you are not satisfied with this response, I want to advise you of your rights. You have the right to submit a written appeal to the head of the Mason County Sheriff's Office who is Sheriff Cole, specifically stating the word "appeal" and identifying the reason or reasons for reversal of this denial.

In addition, you may also seek judicial review of this denial pursuant to MCL 15.240. If you seek judicial review and the court determines the public records are not exempt from disclosure, you have the right to receive attorney fees and damages in an amount not to exceed \$1,000.00.

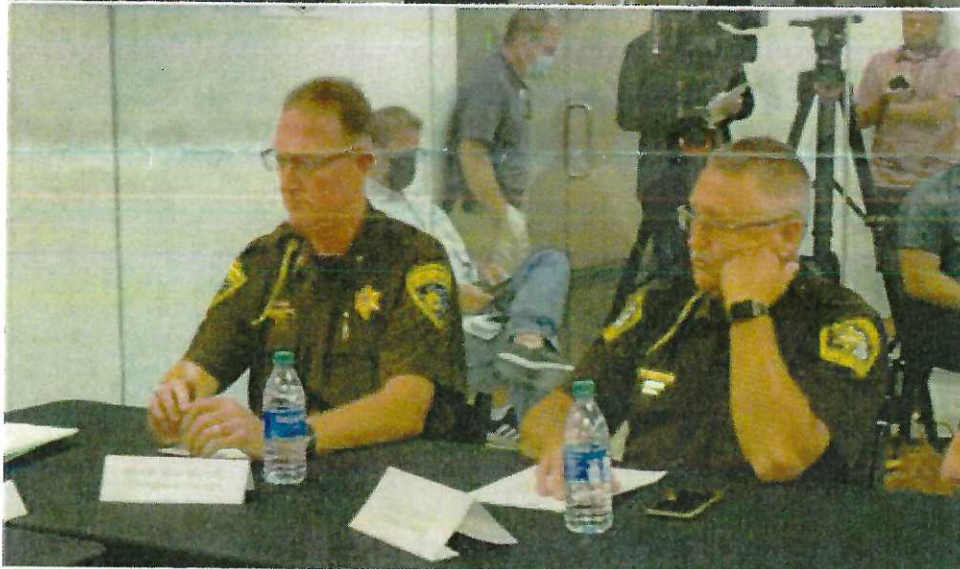

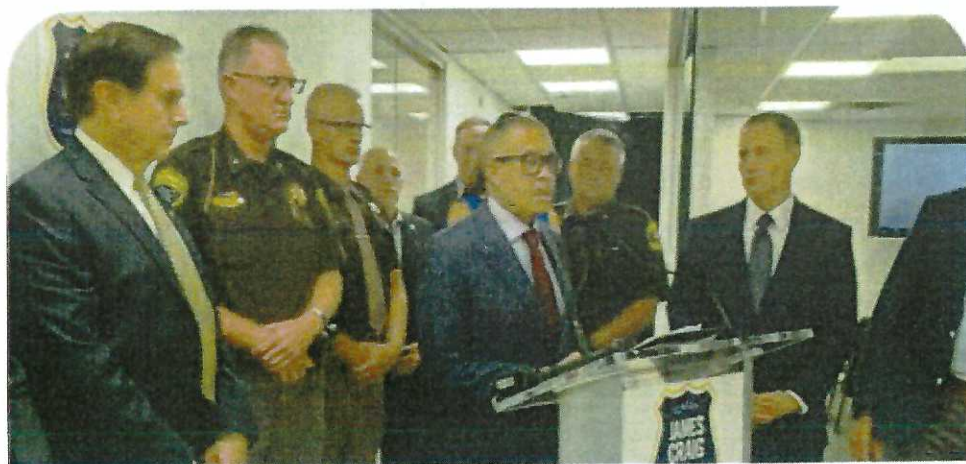
